## Taxes

The parties acknowledge and agree to their respective responsibilities regarding taxes associated with the sale of the vehicle. Sales and other taxes in relation to the purchase of the motor vehicle shall be borne by the parties stipulated by law.

## Odometer Disclosure Statement

Seller certifies to the best of the Seller's knowledge that the Vehicle's odometer reading of \_\_\_\_\_ of the described Vehicle. The Vehicle's odometer was not altered, set back, or disconnected while in the Seller's possession, and the Seller has no knowledge of anyone doing so.

## Miscellaneous Provisions

**Confidentiality.** The terms and conditions contained in this Agreement shall constitute confidential information, The Parties agree to keep confidential the confidential information from any Party not a signatory to this Agreement. In the event that a recipient in this Agreement is compelled by a governmental body, the court, or any competent authority to disclose any of the information herein, the said Party shall promptly notify the other so the latter may be able to seek a protection order or avail itself of any other remedies provided for by law. The provisions of this section shall survive the termination of this Contract.

**Non-waiver.** No waiver or relinquishment of rights shall be considered as having been made unless such waiver is expressed in writing and signed by the waiving party.

**Relativity.** This agreement is binding upon the agents, representatives, successors, or assigns of the parties hereto.

**Separability Clause.** In case any provisions in this Agreement shall be considered by any competent court as invalid, the said invalid provision shall be considered as stricken out and be considered not written, and the rest of the remaining provisions shall remain valid and enforceable.

**Agreement Modification.** No changes or modifications in this Agreement shall be considered as made unless such modification, amendment, or change is executed in writing and signed by the parties hereto.

**Non-Transferability.** No party shall have the sole capacity to transfer any right or obligation under this Agreement unless prior written consent was made by the other.

**Judicial Action.** Any legal action arising from this Agreement shall be filed with the courts of \_\_\_\_\_, to the exclusion of other venues that are hereby expressly and willingly waived by the parties.
