Article 1 - Parties

This Car Rental Agreement (shall be referred as the "**Agreement**" hereinafter), has been signed by and between **ABC Car Rental Inc.** (the "**Company**" hereinafter) with its registered address _____, and _____ (the "**Client**" hereinafter) with its registered address _____, on the date of _____. The Company and the Client shall be referred as the "**Parties**" together and the "**Party**" solely.

The "**Car**" described on the first page of the Agreement has been rented by the Company to the Client under the term and conditions of this Agreement.

Article 2 - Rental Fee and Payment

The daily rental fee of the Car mentioned above is _____.

The total rental fee is paid in advance on the day the Car is delivered to the Client.

The Car will be delivered to the customer with a full fuel tank. Likewise, the fuel tank must be full when the Car is returned. Otherwise, the amount of one tank of fuel will be charged from the amount blocked on the Client's credit card.

Article 3 - General Obligations

- Rental term is at least 1 day (24 hours). Daily rental fee is applied for shorter term rentals. In case of delay, _____ of the daily fee is charged for each additional hour, and if the delay exceeds 3 hours, a full day's fee is charged.
- The Client shall return and deliver the Car on the agreed day. For all extensions, the Client shall apply to the Company and get approval. In extensions made without approval, it has been accepted by the Parties that the Client has illegally kept the Car.
- At the beginning of the rental, a temporary blockage is applied from the Client's credit card in amounts varying according to the Car group as collateral. For this reason, at the start of the rental, Client is also required to present their valid driver's license and available credit card.

- The Client must comply with the applicable laws and regulations during the term of this Agreement. The Client is responsible for all the costs arising from violation of laws and regulations including penalties, towing fees etc.
- In case of damage or malfunction in the rented Car, the Client is responsible for delivering the Car to the authorized service in a safe manner and without increasing the damage. In such a case, the costs and expences shall be paid by the Client.
- The Car, shall not be used in any activities in return for an open or hidden income, in the transportation, possession or other illegal transactions of illegal substances, under the influence of alcohol and/or drugs, in motorsports (racing, speed, rally, strength) , speed trials, etc.).
- Use of the Car by someone other than the Client is forbidden. For persons other than the Client, there is a pre-registration requirement as an additional driver. Any damage arising from the use of the Car by an unregistered person is claimed directly from the Client.

Article 4 - Termination

The Company may terminate this Agreement unilaterally at any time, with a notification to the Client, including via email, written notice or SMS. The notification shall include the demanded return day of the Car. In case of early termination of the Company, the fee for the remaining days shall be returned.

The Client may also terminate the Agreement at any time unilaterally. In case of early termination, the Client shall not demand the daily fee of remaining days.

In long-term rents, if it is understood that the Client is using the car in violation of the provisions of this Agreement or illegally, the Company may terminate the contract immediately and may demand a _____ percent of total rental fee as penalty.

Article 5 - Dispute Resolution

All or any disputes arising out or touching upon or in relation to the terms and conditions of this Agreement, including the interpretation and validity of the terms thereof and the respective rights and obligations of the Parties, shall be settled amicably by mutual discussion.
