## Terms and Conditions

- The Influencer agrees and undertakes to work in full cooperation with the Advertiser within the scope of the Project details and obligations explained above, and to make the necessary effort to maintain and improve the quality of the service it provides.
- The Advertiser agrees and undertakes to cooperate with the influencer within the scope of this Contract, especially to provide accurate and complete information.
- Any activity or situation that might affect the Project will be checked by both parties and if one of the parties becomes aware of such a situation, it shall inform the other party without delay.
- Once the Project is completed, any changes that will be made by any party will require written approval of the other Party.
- In the event that services from third parties are required within the scope of the project, the fees to be paid to third parties are paid \_\_\_\_\_ . The same payment basis shall be applied to video credits, advertising materials, and other marketing materials.
- The complete or incomplete Project shall not be sold or leased to third parties without the written consent of both parties. If both parties agree to sell the Project to a third party, parties have to conclude a written agreement detailing payment terms and revenue share.

→ In case any provision in this Contract shall be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby and such provision shall be ineffective only to the extent of such invalidity, illegality or unenforceability.
