

# Dog Boarding Contract

This **Dog Boarding Agreement** ("**Agreement**") is entered into on \_\_\_\_\_ ("**Effective Date**") between:

**Facility**

**Owner**

The Facility and the Owner are collectively referred to as the "**Parties**" and individually as a "**Party**".

## 1. Purpose of Agreement

The purpose of this Agreement is to set out the terms under which the Facility will provide temporary boarding, care, and supervision services for the Owner's dog(s).

## 2. Dog Information

The Owner agrees to provide accurate and complete information regarding the dog(s) to be boarded:

The Owner confirms that all information provided is true and up to date.

### 3. Boarding Period

The Facility agrees to board the dog(s) for the following period:

Any extension of the boarding period must be agreed to by the Facility in advance.

### 4. Services Provided

During the boarding period, the Facility will provide:

- Safe and secure housing
- Regular feeding in accordance with Owner instructions
- Access to water at all times
- Reasonable exercise and socialization, unless otherwise instructed
- General supervision and care

Additional services such as grooming, training, or special care will only be provided if agreed in writing and may incur additional charges.

### 5. Owner Responsibilities

The Owner agrees to:

- Provide sufficient food, medications, and instructions for the dog's care
- Ensure that the dog is in good health and free from contagious conditions at the time of boarding
- Provide proof of current vaccinations, including but not limited to rabies, distemper, and bordetella
- Disclose any behavioral issues, including aggression, anxiety, or escape tendencies

The Owner acknowledges that failure to disclose relevant information may result in termination of services.

## 6. Fees and Payment

The Owner agrees to pay the Facility for boarding services as follows:

## 7. Veterinary Care

If the dog becomes ill or injured during the boarding period, the Facility is authorized to seek veterinary care as deemed reasonably necessary.

The Owner agrees that:

- All veterinary costs shall be the responsibility of the Owner
- The Facility will make reasonable efforts to contact the Owner prior to treatment, except in emergencies where immediate care is required

## 8. Risk and Liability

The Owner acknowledges that:

- Boarding involves inherent risks, including illness, injury, or stress despite reasonable care
- The Facility will exercise reasonable care but does not guarantee against all risks
- The Facility shall not be responsible for loss, injury, or illness except where caused by its failure to provide reasonable care.

The Owner remains responsible for any damage or injury caused by the dog to persons, property, or other animals.

## 9. Abandonment

If the Owner fails to collect the dog within \_\_\_\_\_ days after the agreed check-out date and does not communicate with the Facility, the dog may be considered abandoned.

In such case, the Facility may take appropriate action, including rehoming the dog, in accordance with applicable laws. The Owner remains responsible for all costs incurred up to that point.

## 10. Termination

Either Party may terminate this Agreement before the boarding period begins by providing reasonable notice.

The Facility may terminate the Agreement during the boarding period if:

- The dog poses a risk to staff, other animals, or itself
- The Owner has provided false or incomplete information

In the event of termination, the Owner shall promptly arrange for the dog's collection and remains responsible for all fees incurred.

## 11. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of \_\_\_\_\_.

Any disputes arising out of or in connection with this Agreement shall be resolved through good faith negotiations between the Parties. If unresolved, the dispute shall be submitted to a competent court of jurisdiction.

## 12. Entire Agreement

This Agreement constitutes the entire understanding between the Parties and supersedes any prior discussions or agreements relating to the subject matter.

## 13. Amendments

This Agreement may only be amended by a written document signed by both Parties.

## 14. Acknowledgment

By signing this Agreement, the Owner confirms that they have read, understood, and agree to all terms and conditions contained herein.
