

# Dog Training Contract

This **Dog Training Contract** ("**Agreement**") is entered into on \_\_\_\_\_ ("**Effective Date**") between the parties below:

Trainer and Owner may be referred to individually as a "**Party**" and collectively as the "**Parties.**"

## 1. Purpose

The purpose of this Agreement is to set out the terms under which the Trainer will provide dog training services to the Owner for the dog identified below.

## 2. Dog Information

The Owner confirms the following details regarding the dog:

The Owner represents that the information provided is accurate and complete.

### 3. Services

The Trainer agrees to provide the following training services:

The Trainer will use reasonable professional skill and care in delivering the services but does not guarantee specific outcomes, as results depend on multiple factors including the Owner's participation and the dog's temperament.

### 4. Owner Responsibilities

The Owner agrees to:

- Follow all training instructions and guidance provided by the Trainer
- Attend scheduled sessions on time and participate actively where required
- Ensure the dog is healthy, vaccinated, and fit for training
- Inform the Trainer of any behavioral issues, aggression, or medical conditions
- Use appropriate equipment as recommended by the Trainer

Failure to comply with these responsibilities may affect training outcomes and does not relieve the Owner of payment obligations.

### 5. Fees and Payment

The Owner agrees to pay the Trainer as follows:

## 6. Cancellation and Rescheduling

The Owner must provide at least \_\_\_\_\_ notice to cancel or reschedule a session. Sessions missed or canceled without sufficient notice may be forfeited without refund.

The Trainer reserves the right to reschedule sessions due to unforeseen circumstances and will provide reasonable notice.

## 7. Health and Safety

The Owner confirms that the dog:

- Is in good health and free from contagious conditions
- Has received appropriate vaccinations
- Does not pose an undisclosed risk to people or other animals

The Trainer reserves the right to refuse or discontinue services if the dog presents a safety risk.

## 8. Liability

The Owner acknowledges that working with animals carries inherent risks. To the extent permitted by law:

- The Trainer shall not be responsible for injuries, damages, or losses caused by the dog during or after training
- The Owner remains responsible for the dog's behavior at all times

The Trainer will take reasonable precautions to ensure safety during training sessions.

## 9. Equipment and Methods

The Trainer may recommend or use specific training tools or methods. The Owner agrees not to use any equipment or technique without proper instruction.

The Trainer will use humane, professional training methods and will not employ practices intended to harm the dog.

## 10. Term and Termination

This Agreement begins on the Effective Date and continues until completion of the agreed services unless terminated earlier.

Either Party may terminate this Agreement:

- For cause, if the other Party materially breaches its obligations and fails to correct the issue within a reasonable time after notice
- Without cause, by providing \_\_\_\_\_ written notice

Upon termination:

- The Owner remains responsible for payment for services already rendered
- Any prepaid sessions may be refunded at the Trainer's discretion, subject to deductions for completed services

## 11. Confidentiality

The Trainer agrees to keep any personal information provided by the Owner confidential and to use it only for the purpose of delivering services under this Agreement.

## 12. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of \_\_\_\_\_.
