This **Esports Contract** ("**Contract**" hereinafter) has been signed by and between;

Terms and Conditions

- **The Contract** - The purpose of this Contract is to establish an engagement between the Organization and and the Player regarding the Player's representation of the Organization in competitive tournaments, events, social media channels and related activities within the esports industry.
- **Term** - This Contract shall commence on _____ and remain in effect for an initial term of _____, renewable by a mutual agreement between the parties upon completion of the initial term.
- **Scope** - The Player agrees to compete in designated esports tournaments and events as a representative of the Organization and also agrees to engage in practice sessions and team-related activities as required by the Organization.
- **Compensation** - The Player shall be paid base salary of _____ monthly. The Player shall also be paid _____% of the tournament prize winnings. The Player may claim a share of the sponsor revenues he brings to the Organization but cannot claim a share of the sponsorship revenue of sponsors brought by the Organization.

- **Compliance** - The Player accepts and undertakes to act in accordance with the ethical rules and relevant legal legislation in all competitions and tournaments in which he will participate on behalf of the Organization. In case of violation of ethical rules and/or legal regulations, the Organization may terminate this Contract unilaterally without notice. The Player shall also comply with all rules and guidelines set forth by tournament organizers and relevant gaming leagues.
- **Other Obligations** - The Player agrees to make reasonable effort to train and practice. The Player shall refrain from any behavior that would damage the Organization's brand in any way. The Player cannot participate in competitions on behalf of another organization in the same category during the period of this Contract.
- **Termination** - Termination of this Contract may occur under circumstances of material breach, mutual agreement, or expiration of the agreed-upon term.
- **Confidentiality** - Both parties shall maintain the confidentiality of proprietary and all kind of financial information disclosed during the term of this Contract.
- **Entire Agreement** - This Contract contains the entire understanding between the Parties and supersedes all prior and collateral communications and understandings between the Parties with respect thereto.
- **Modifications** - No change, modification, alteration, or addition to this Agreement shall be binding unless in writing and signed by authorized representatives of both Parties.
- **Governing Law and Dispute Resolution** - This Contract shall be governed by the laws of the applicable federal laws and the laws of the State of _____. Any disputes arising from this Contract shall be resolved through mediation. In cases where mediation does not bring a solution, the parties accept the jurisdiction of _____ courts.
