TERM AND CONDITIONS

1. Scope of Contract

Within the scope of this Contract, the Florist agrees to provide the Client with fresh plants, flowers, and floral products (“**Products**”) grown by the Florist. Products are delivered by order and delivery processes are also organized by the florist. The Products will include a variety of items as agreed between the Parties and listed on the Florist’s current price list, which may be updated periodically.

2. Term and Termination

This Contract shall begin on the date it is signed by both Parties and shall remain in effect indefinitely unless terminated by either Party. Either Party may terminate this Contract at any time, for any reason, by providing _____ written notice to the other Party. Either Party may terminate this Contract immediately upon written notice if the other Party breaches any material term of this Contract and fails to remedy such breach within _____ of receiving written notice. Upon termination, any outstanding payments for Products already delivered shall be due and payable immediately.

3. Pricing and Payment

Payment for Products shall be determined in accordance with the Florist’s current price list, which will be sent to the Client by email on the first day of each month. The Florist may update the price list with a _____ written notice to the Client. The Client shall be eligible for a discount of _____ % on bulk orders, defined as purchases exceeding _____ in a single order.

Payment for Products shall be due within _____ of receipt of an invoice from the Florist. Payments shall be made via _____

4. Risk of Loss

Title to the Products and risk of loss or damage shall transfer from the Florist to the Client upon successful delivery and acceptance at the specified delivery location. Delivery shall be deemed complete when the Products have been handed over to the Client or its authorized representative and have been inspected and accepted.

5. Delivery

The Florist is responsible for delivering the Products to the Client and shall assume all risk of loss, theft, or damage to the Products during transit. The Florist shall use reasonable care in packaging and transporting the Products to minimize risk of damage and shall maintain appropriate insurance coverage during transportation.

If delivery is made using a third-party carrier arranged by the Florist, risk of loss shall transfer to the Client upon the third-party carrier's confirmation of delivery to the Client's specified location.

6. Product Quality

The Florist undertakes all Products supplied are grown and harvested in compliance with applicable laws and industry standards and the Products do not cause any direct or indirect harm to human health. The Products sold are inedible. The Products are of high quality, fresh, and suitable for resale in a florist shop. The Florist has the right and authority to sell the Products to the Client.

7. Non-Exclusivity

This Contract is non-exclusive, and both Parties retain the right to enter into similar agreements with other parties. The Florist may sell Products to other clients, and the Client may procure products from other vendors at their discretion.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____.

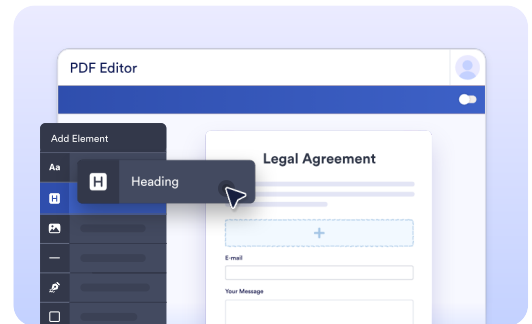

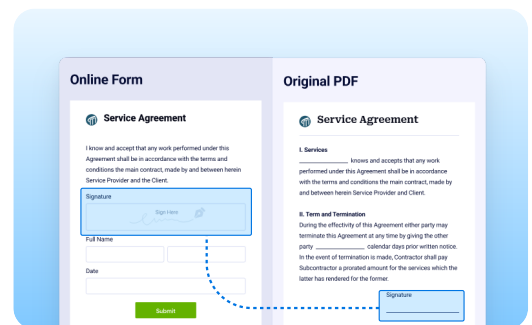

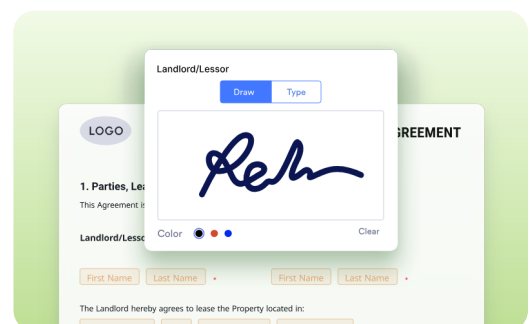
