

# Foster Agreement

This **Pet Foster Agreement** (the "**Agreement**") has been signed by and between the Parties below;

The defining characteristics of the pet are as follows;

Within the scope of the subject matter of this Agreement, the Parties agree as follows;

### 1. Duty not to Sell

Foster Parent agrees that the pet is in a "foster" and shall not be sold, adopted, or given to another party without a just cause.

### 2. Appointments

Foster Parent shall be responsible in maintaining the pet's health including the schedule of appointments given for the pet's spay/neuter, vaccinations, among others, as scheduled with the designated veterinarian. In case of unavailability, it is the responsibility of the Foster Parent to notify the veterinarian as early as possible to set another arrangement within the reasonable timeframe for the veterinarian.

The Shelter reserves the right to take the pet back into the rescue without refund to any cost by the Foster Parent should the latter violate any of the responsibilities set in this Agreement.

### 3. Pet Care

Foster Parent agrees to take care of pet in a humane manner as such a responsible guardian.

#### **4. Period of Adoption**

Foster Parent agrees that to foster the above-named pet until any of the following has been met:

1. Pet has been neutered/spayed
2. Foster Parent has completed the foster to adopt period,
3. Pet is given a place for a permanent adoptive home,
4. Until an agreed-upon date by the center and the Foster Parent.

Foster Parent may likewise decide to cease this Agreement at anytime provided that there has been given 2 weeks prior notice to the Shelter.

#### **5. Responsibility to Present Pet**

It shall be the responsibility of the Foster Parent to let the pet appear in adoption events. In case Foster Parent is not available to participate in the event, it shall be the responsibility of Foster Parent to notify the center of the unavailability.

#### **6. Supervision**

It shall be the responsibility of Foster Parent to ensure that the pet is well supervised during outdoor activities, with strangers, children, including other pets or animals . Pet shall have a collar and proper ID at all times especially during outdoor activities.

#### **7. Name of Pet**

Foster Parent agrees that the name of the pet shall be maintained as \_\_\_\_\_, and shall not, in any way be changed during the period of his/her care of the pet as foster parent.

#### **8. Food and Water**

Foster Parent agrees that it is his/her responsibility to ensure that pet is properly nourished with food and water every day.

#### **9. Escaped or Missing Pet**

In case the pet managed to escape or runs away, Foster Parent shall notify the Shelter immediately in order to coordinate a search and rescue for the said pet.

#### **10. Pet Medical Care**

It shall be the responsibility of the Foster Parent to notify the center in case of any health or medical condition that requires attention with regard to the pet. Any costs or expenses relative to the treatment shall be shouldered by the Foster Parent. The same shall apply if in case that there are other pets in the Foster Parent's home the Foster Parent shall ensure that other pets are up to date with their vaccinations.

### 11. Prohibition From Letting Go with Strangers

In ensuring safety, the Foster Parent shall not allow the pet to go with anyone, except himself/herself, the family member, or any member of the pet care center.

### 12. Pet is a Companion

Foster Parent agrees that the pet is a companion animal and must live inside the Foster Parent's home, and not outdoors.

### 13. Foster Parent Personal Updates

It shall be the responsibility of Foster Parent to ensure that the Shelter is updated with regard to Foster Parent's address and contact information.

### 14. Relinquishment of Foster Parent Responsibilities

It shall be the responsibility of the Foster Parent to notify the pet care center in case Foster Parent is no longer willing to take care of the pet. Foster Parent shall notify the Shelter 2 weeks prior the return of the pet in order to have proper arrangement and for the purpose of finding the pet a new foster parent.
