

Gym Membership Contract

I. Parties

This **Gym Membership Contract** ("**Contract**") has been signed by and between the following parties;

This Contract determines the Member's use of the facility(s) owned by the Sports Club and the procedures and principles regarding this use.

II. Membership Packages

The membership packages designed to meet the Member's fitness needs and lifestyle preferences are as follows. Within the scope of this Contract, the Member choose the checked membership package.

If the Member wants to change its membership type, he/she shall pay the price gap which will be calculated in accordance with the usage period of the current package.

III. Payment

The total fee for the selected membership package is _____. This amount shall be paid in cash or by credit card in _____ equal installments.

The Member acknowledges and agrees to pay any additional charges for optional services or amenities, including but not limited to personal training sessions, equipment sales, and long term locker rentals.

In the event that any of the installments or other fees are not received by the due date, the Sports Club reserves the right to apply a late payment fee of _____ or suspend the Member's access to gym facilities and services until payment is received in full.

IV. Cancellation and Refund Policy

The Member may cancel their gym membership at any time by providing written notice to the gym. Membership fees are non-refundable except the cases defined below. No refunds will be provided for unused portions of the membership term.

If the member is unable to use gym facilities and services due to a medical condition, injury or disability verified by a licensed medical institution, a prorated refund may be provided for the unused portion of the membership term.

If the member relocates to an area outside of a reasonable distance from the gym facilities, and the Member properly submits documents of this relocation, a prorated refund may be provided for the unused portion of the membership term.

If the Sports Club permanently closes or makes significant changes to its facilities or services that materially affect the Member's ability to use the membership, full refund may be provided for the unused portion of the membership term.

Refunds, if approved by the Sports Club, are made within _____ business days after the request is received by the Sports Club, using the method the member paid.

V. Rules and Regulations

- **Working Hours** - The facility(s) is open between _____ and _____ on weekdays and weekends. The Sports Clup may change or re-determine its working hours at any time and make different arrangements for different departments. However, the duration that the facility is open cannot be less than _____ hours during the day.
- **Alterations to Facility** - Sports Clup may make alterations, renovations, repairs or innovations in the facility from time to time. It may partially limit, stop or close the use of facilities, services and activities. Unless the use of all facilities, services and activities is completely stopped and closed, no compensation shall be paid to the Member.
- **Proper Clothing** - Member is required to wear appropriate athletic attire and athletic footwear while using gym facilities. Bare feet, open-toed shoes, jeans, and clothing with offensive language or graphics are not permitted.
- **No Commitments** - The Sports Club has no written or verbal commitment to Member on issues such as weight loss, weight gain and health improvement.
- **Health Conditions** - The Member declares and undertakes that their health condition is suitable for doing sports and using the facility activities, that they do not have a disease that would prevent them from doing sports, and that participating in such exercises will not harm their health and physical condition.
- **Hygiene** - Member is expected to maintain personal hygiene and cleanliness while using gym facilities, including showering before entering pools or hot tubs, using towels to wipe down equipment, and disposing of trash properly.
- **Personal Belongings** - Member is responsible for safeguarding their personal belongings and valuables. The Sports Club is not liable for any loss, theft, or damage to personal property left unattended in facility(s).

- **Equipments** - Member must use gym equipment in a safe and responsible manner, following instructions and guidelines. Equipment must be wiped down and returned to its proper location after use.
- **Rules of Conduct** - While Member is in the facility, it is strictly forbidden to engage in bad and ugly acts that are disrespectful to other members and the facility staff, to use abusive and slang words and shouts, to use the facilities' areas while intoxicated or humiliating behavior. Member must comply with the applicable law, all the rules and practices. Otherwise, membership must be terminated immediately without any refund.
- **Group Classes** - Member participating in group fitness classes must arrive on time and follow the instructions of the instructor. Late arrivals may not be permitted to join the class once it has started.

VII. Governing Law and Dispute Resolution

This Contract shall be governed by and construed in accordance with the laws of State of _____ . The parties hereby agree that any dispute, controversy, or claim arising out of or relating to this Contract, shall be exclusively submitted to the jurisdiction of the courts located in _____ .
