Services

The Photographer agrees to provide no fewer than _____ proofs for the Client to view after the Services and is not required to provide more than _____ images. The selection of the images delivered to the Client is left to the discretion of the Photographer.

The Client agrees to assist the Photographer during the Services in order to obtain the desired photographs and videos. The Client shall assist and cooperate with the Photographer on specifying persons and/or scenes to be photographed, taking time to pose for photographs, pre-shoot consultations etc. The Photographer shall not be responsible for photographs not taken as the result of Client's failure to provide reasonable assistance and cooperation.

After the Event, the Photographer shall perform basic post-processing or digital editing services on these photographs where artistically necessary. The final photographs shall be delivered no more than _____ days after the Event.

The Client shall receive photos via _____ with print release for personal use. _____ includes images for printing and may be used on various social media platforms.

The Client is entitled to pay a non-refundable \$ _____ as a Reservation Deposit and as it shall be a slot reserved for the Client only and the Photographer shall not make any reservations at the same slot, the Reservation Deposit is non-refundable, even if the date is changed or event canceled for any reason, including acts of God, fire, strike, and extreme weather.

Pre-Event Consultation

The parties agree to a pre-event consultation before the Event in order to finalize the actual shooting times, locations, and Client's request list (in writing) for specific photographs. The Client will be responsible for, or have someone designated, to identify people of whom specific photographs are desired. The Photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for group photographs.

Shooting Time/Addition

The photography schedule and selected methodology are designed to accomplish the goals and wishes of the Client in a manner enjoyed by all parties. The Client and the Photographer agree that cheerful co-operation and punctuality by all members of the Event staff are therefore essential to that purpose. Shooting commences at the scheduled start time agreed by both parties. Should additional photography and/or travel time, that is not included in the agreed package, be requested by the Client, it will be charged out at the rates specified in the Assignment Package, rounded to the nearest half hour.

House Rules

The Photographer is limited by the guidelines of event officials and/or event location site management. The Client agrees to accept the technical results of their imposition on the Photographer. Negotiation with the officials for moderation of guidelines is the Client's responsibility; the Photographer will offer technical

Cancellation

In the event the Client cancels the Photography Session with less than forty-eight (48) hours' notice, Photographer will retain the non-refundable deposit of \$_____.

Photographer reserves the right to cancel the Photography Session due to unforeseen circumstances including, but not limited to: inclement weather, illness, emergency, or any other conditions which the Photographer deems may adversely affect the quality of the Photography Session. In the event Photographer cancels the scheduled session, the \$_____ will be applied to a re-scheduled session that is agreed-upon by the parties.

Copyright

The Photographer has the non-exclusive, irrevocable, perpetual, and international rights to use, publish, crop, modify, reproduce and distribute any photos taken at the Event, in print and in all other formats, methods, and technologies of distribution of any kind, now known or later developed. Therefore, it is strictly prohibited for the Client to modify, copy, or reproduce the photographs without the written permission of the Photographer.

Indemnification

The Client agrees that the Photographer cannot guarantee certain poses or coverage quality and that the Photographer shall in no way be held responsible for compromised coverage due to interference from third parties or the environment.

If the Photographer is unable to perform the Services in this Agreement due to any cause outside its control, such as fire, flood, casualty, an act of God, or any other reasonable cause, the Client agrees to indemnify the Photographer for any loss, damage or liability.

The Client also agrees to indemnify and hold harmless the Photographer for any liability, damage, or loss related to technological failure, including cameras, hard drives and memory cards. The Photographer agrees to take all reasonable steps to prevent data loss but is not liable for loss of data for technical failure.

Independent Contractor

The Photographer and its employees, agents, representatives, and subcontractors are independent contractors and not employees or agents of the Client. The Client will not be bound by any acts or conduct of the Photographer or its employees, agents, representatives, or subcontractors. The Photographer agrees to include this provision in all its subcontracts under the Agreement.

Model Release

The Client grants permission to the Photographer and its assigns, licensees, and sublicensees, permission to use Client’s image or likeness in any and all forms of media for commercial purposes, advertising, trade, personal use, or any and all other uses. Therefore, Photographer may use Client’s likeness and image on Photographer’s website or other advertising. The Photographer may sell photos containing Client’s likeness to third parties.

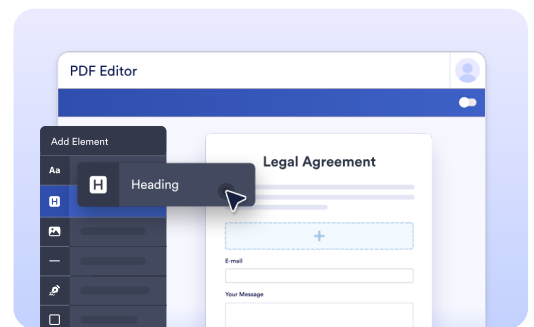

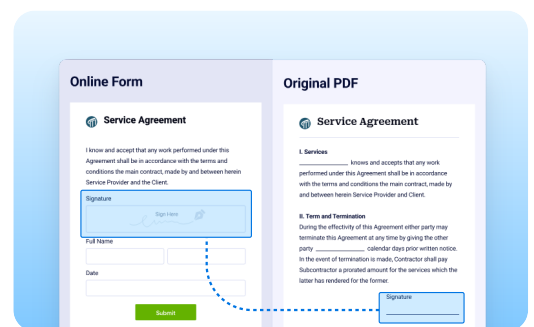
