Term and Conditions

This Wedding Photography Contract ("**Contract**") is by and between the Bride & Groom (or "**Client**") and the Photographer. The parties have agreed that the Photographer will provide Bride & Groom with the services specified within the scope of the package selected above on the day of the event, the details of which are stated above.

PAYMENT TERMS:

The total fee for the services is _____, with a non-refundable deposit of _____ due upon signing this Contract. The remaining balance of _____ must be paid by _____ at the latest. The Photographer accepts payment through _____. Failure to pay the any of the payments by the due date may result in the cancellation of services, and the deposit will not be refunded.

CANCELLATION:

If the event is cancelled within three months of the wedding date, the Client shall pay the balance of the contract due to the high probability that the Photographer will not be able to further book that date. Once a balance is paid, it is non-refundable, except in extreme circumstances. Any other arrangements shall be discussed between the Client and Photographer. All arrangements will be put in writing. The Client will be given the chance to reschedule but cannot be pushed ahead of other reserved clients.

If the Photographer must cancel, all payments received will be refunded, and reasonable efforts will be made to recommend another professional photographer.

CONFIRMATION:

The booking is considered confirmed only when the signed contract and non-refundable deposit are received by the Photographer. The Photographer will not hold any date without these items together.

COMMUNICATIONS:

The Client and Photographer agree to maintain clear and timely communication regarding the event. All significant changes, requests, or updates must be communicated in writing. The Bride and Groom will outline broadly what is required and Photographer will advise on planning, logistics and timings where needed.

PAPARAZZI WEDDING GUESTS:

The Photographer is not responsible for the actions of wedding guests that may interfere with the photography process. It is the Client's responsibility to inform guests to allow the Photographer to work unobstructed. In the spirit of cheerful cooperation the bride and groom agree to give Photographer precedence over your guests in order to take the photographs required for the wedding services described above. The Photographer cannot be held liable for a lack of wedding photos if the Heline's work has been continually interrupted by guests taking their own photos of the bride and groom.

SCHEDULE:

The Client will provide a detailed timeline for the event, including key moments to be captured. The Photographer will make every reasonable effort to follow this schedule but cannot guarantee specific shots due to unforeseen circumstances.

HOUSE RULES:

The photographer is sometimes limited by rules imposed by registrars, ministers and venue management as to what can and cannot be done. For example some ministers insist that no flash photography is allowed, and others will insist that the photographer shoot from a specific location. In such circumstances the Client agree to accept the technical limitations that may be imposed on the equipment used. The Client is advised to make themselves aware of the rules of the venue concerned and if necessary negotiate with the individuals concerned.

COPYRIGHT LAW:

The Photographer retains the copyright to all images captured during the event. The Client is granted a non-exclusive, perpetual license to use the photographs for personal use. Commercial use, including selling or licensing the images, is prohibited without written consent from the Photographer.

MODEL RELEASE:

The Client grants the Photographer and their representatives the irrevocable and unrestricted right to use, publish, and distribute photographs taken during the wedding for promotional, advertising, and portfolio purposes in any medium, including but not limited to websites, social media, print, and digital publications. The Photographer agrees to maintain the privacy of the Client. If the Client wishes to restrict the use of certain images, they must communicate this in writing before the event. The Photographer will not sell or license the photographs to third parties without the Client's express written consent.

LIMIT OF LIABILITY:

The Photographer’s liability for any loss or damage arising out of this Contract is limited to the total amount paid by the Client. The Photographer is not liable for circumstances beyond their control, including but not limited to equipment failure, acts of nature, or unforeseen emergencies. The Photographer will take all reasonable care and precautions to provide high-quality services; however, they are not responsible for compromised coverage due to interference from third parties, restrictions at event locations, or the failure of subjects to cooperate during photography sessions. In the unlikely event of severe medical, accidental, or other emergencies that prevent the Photographer from fulfilling their obligations, they will make every reasonable effort to secure a replacement photographer of comparable skill and style. If a replacement cannot be found, liability is limited to a full refund of all payments made by the Client.

DELIVERY OF ASSETS:

The Photographer will deliver edited photographs to the Client within _____. The final deliverables will be provided in _____. The Photographer will retain backups for _____ but is not responsible for archiving images indefinitely.

MISCELLANEOUS:

- No modification or alteration of any kind in this Contract shall be considered as valid and enforceable unless such modification or alteration is agreed upon and signed by the parties hereto.
- If any of the clauses of this Contract is found to be invalid, illegal, or unenforceable, the parties desire that the remainder of the agreement, other than the provision determined to be unenforceable, remain in full force and effect.
- This Contract shall be governed and construed in accordance with the applicable laws of _____.
