

# Actors Contract

## 1. Parties

This **Actors Contract** (shall be referred as "**Contract**" hereinafter) has been signed by and between the parties below, under the specified term and conditions;

## 2. Engagement

The Producer and the Actor have agreed that the actor will play the role of \_\_\_\_\_ in the \_\_\_\_\_ ("**Project**" hereinafter), which will be shot, marketed and sold by the Producer. The scenario of the Project is approved by both the Producer and the Actor. The Actor knows and accepts the details of the scenario and shall not demand any changes or shall not avoid to act as required by the scenario.

## 3. Term and Schedule

The duration of the engagement between the Producer and the Actor is \_\_\_\_\_, starting from \_\_\_\_\_. This period covers the shooting, broadcast time and the events that will take place within the scope of the Project. The Actor agrees to perform the services required under this Contract during the specified performance period, which shall include rehearsal dates, shooting or performance dates, and any other dates as mutually agreed upon by the Actor and the Producer.

The Producer reserves the right to change the schedule, provided reasonable notice is given to the Actor. The Actor acknowledges that changes in the schedule may be necessary due to production requirements, script revisions, or unforeseen circumstances.

The Actor shall be entitled to reasonable breaks and rest periods as required by applicable labor laws and industry standards during all production-related activities. All transportation, accommodation and everyday essentials related with the Project shall be borne by the Producer.

#### 4. Compensation

The Actor shall be paid a base salary of \_\_\_\_\_ per month until the end of engagement period. Payments shall be made on \_\_\_\_\_ day of the month at the latest, via \_\_\_\_\_.

The Producer may pay a bonus of \_\_\_\_\_, if the profit of the Project exceeds \_\_\_\_\_. Also, incentive payments may be made by the Producer. Bonuses and incentive payments are not recurring payments and are not taken into consideration in the calculation of the Actor's receivables arising from labor law.

If the monthly salary is not paid on the due date, the Actor may send a notice to the Producer. If the payment is not made within 7 days from the notice date, the Actor is deemed to have terminated the contract without any further action or notice.

If the Project revenue exceeds \_\_\_\_\_, the Actor will also be paid \_\_\_\_\_ as share out of profit.

The Producer shall deduct and withhold from the Actor's compensation any applicable taxes, social security contributions, or other statutory obligations as required by law.

#### 5. Confidentiality

The Actor acknowledges and agrees that during the course of their engagement with the Producer, he/she may have access to confidential information, which may include, but is not limited to, scripts, storylines, character development, production details, financial information, trade secrets, and any other information disclosed or learned during the engagement (collectively "**Confidential Information**" hereinafter). The terms of this Contract and especially the financial issues are also considered as Confidential Information.

The Actor undertakes to strictly maintain Confidential Information confidential and not to disclose, distribute, reproduce, or otherwise make available the Confidential Information without prior written consent from the Producer except as required by law.

Obligation of confidentiality shall survive for an indefinite period of time. The Actor knows and accepts that, in case of any breach of this obligation, the Producer shall be entitled to seek injunctive or other equitable relief in addition to any other remedies available at law or in equity.

## 6. Restrictions

During the engagement period, the Actor shall not engage in any other projects that directly compete with the Project. Within this scope, the Actor cannot accept role offers of a similar role, and cannot be in another project as a lead role \_\_\_\_\_ months before and \_\_\_\_\_ months after the Project will start to be published. The Actor cannot act in commercials without the Producer's prior written approval within the engagement period.

If the Actor breaches any of the restrictions in this clause, the Producer may terminate the Contract immediately with a written notice. Also, the Producer shall be entitled to seek injunctive relief, damages, or any other remedies available at law or in equity.

## 7. Termination

Either party may terminate this Contract immediately upon written notice if the other party commits a material breach of any provision of this Contract and fails to remedy such breach within a specified period of \_\_\_\_\_ days after receiving written notice specifying the breach.

In the event that the performance of this Contract is prevented by force majeure events, including but not limited to acts of God, natural disasters, war, pandemic, strikes, or any other events beyond the control of the parties, either party may terminate this Contract by providing written notice to the other party. In such cases, the termination shall be effective immediately upon the date of the notice.

## 8. Intellectual Property

All rights, title, and interest of all intellectual property created, developed, or contributed by the Actor in connection with their performance under this Contract shall be the exclusive property of the Producer. By signing this Contract, the Actor agrees to transfer all intellectual property rights to the Producer.

The Producer shall have the exclusive right to use, reproduce, distribute, publicly display, publicly perform, modify, adapt, and exploit the intellectual property in any manner.

## 9. Entire Agreement

This Contract contains the entire agreement and understanding among the parties hereto with respect to the subject matter of this Contract, and supersedes all prior and contemporaneous agreements, understandings, inducements and conditions, express or implied, oral or written, of any nature whatsoever with respect to the subject matter hereof.

## 10. Notifications

All notifications and required communications with respect to this Contract shall be sent to respective addresses and email addresses indicated in the first page of this Contract. Parties are obliged to inform the other party promptly in case of an address change. Otherwise, the notification made to the indicated addresses shall be deemed valid.

## 11. Governing Law

This Contract shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_ . Venue for any action arising in accordance with this Contract shall be in \_\_\_\_\_ .
