- The Buyer agrees and undertakes that he/she will keep the dog in good condition, will not use it for commercial purposes and production and will not abandon it.
- The Breeder cannot be held responsible for the cat's illness or death after the date of this Bill of Sale. In this case, the Buyer cannot claim a refund and/or compensation.
- The cat's care and follow-up by a veterinarian is the Buyer's responsibility.
- This Bill of Sale constitutes the entire agreement of the Parties relating to the subject matter hereof and supersedes all prior communications, representations, or agreements, oral or written, by the Parties relating thereto.
- Any dispute arising out of or in connection with this Bill of Sale, shall be resolved in accordance with the federal law and the applicable laws of the State of _____.
