Pet Liability

The Owner of the Pet shall be deemed the authorizing agent for all grooming instructions and procedures for the Pet, and shall be referred to as "Owner".

Medical Conditions & Medications

The Owner understands and acknowledges that grooming procedures can sometimes expose hidden medical problems as well as aggravate the existing ones. The Owner agrees to inform the Company of any medical, physical, or emotional issues, allergies, sensitivities, or pre-existing conditions. These conditions may include, but are not limited to, prior surgeries, hip and/or joint issues, warts, moles, ear infections or skin problems.

Because senior pets and pets with health problems have a greater risk of injury, these pets will be groomed for comfort and cleanliness, as our company will not compromise any pet's health and/or wellbeing to achieve "the perfect groom".

Our Company will not be responsible for accidents or injuries to elderly or health compromised pets during their grooming. By signing below, the Owner agrees that the Company has permission to groom their senior or health-compromised pet, and has discussed any and all (past and present) health problems to the best of their knowledge.

Current Vaccination Information

By signing this consent form, the Owner confirms that their pet is currently on Rabies, Distemper (for cats), and Bordetella (for dogs) vaccination. Proof of vaccination must be provided to the Company prior to grooming.

Aggressive Pets

By signing this consent form, the Owner agrees to inform the Company staff of potential aggressive behavior towards people or animals that their pet may display. In the event that a pet is aggressive, a muzzle may be used. Muzzles are not harmful to pets, but keep groomers and your pet safe. The Company reserves the right to refuse or stop services for aggressive pets at any time before or during the grooming procedure.

Accidental Injury

Although groomers use extreme caution and care in all situations, grooming equipment is sharp and there is always potential for accidents, including cuts, nicks, scrapes, and quicking of nails. By signing this consent form, the Owner confirms that he/she understands the risk of accidental injury to his/her pet.

Fleas

If fleas are found on your pet, the Company will give a one off flea treatment (_____) at an additional minimum cost of \$ _____. This cost covers the medication and administration to ensure our grooming salon is free of active parasites. _____ kills the fleas on the pet only. If there are fleas in the home area, the treatment will not protect your pet once they leave the establishment.

Mat Removal

The Owner agrees that Pets with matted coats require additional care and attention, as mats can be difficult to remove. The groomer will attempt to brush out mats, but severe matting may require the pet be shaved. Intense matting or brushing can cause dermatitis, irritation, and brush-burn, along with nicks or cuts. The Owner consents to mat removal procedures, and acknowledges risk to the Pet.

Late Pick Up

The Company shall advise a timeframe anticipated with regards to the condition of the Pet for the Owner to pick up the Pet. The Owner understands that grooming can be a very time consuming and unpredictable process depending on the Pet's behavior, as well as condition of the coat, and when the Owner arrives for the appointments.

The Company agrees that the groomers will do their best to manage the approximate time given. The Owner agrees to pick up the Pet within _____ hour of the time the Owner is informed the pet is ready. The Owner agrees to pay a fee of \$_____ for the remaining Pet after given time. The Company does not hold responsibility for the incidents that may occur to the Pet whilst awaiting collection.

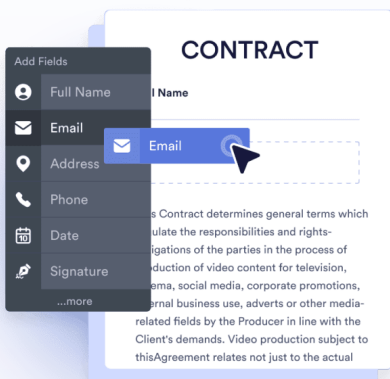

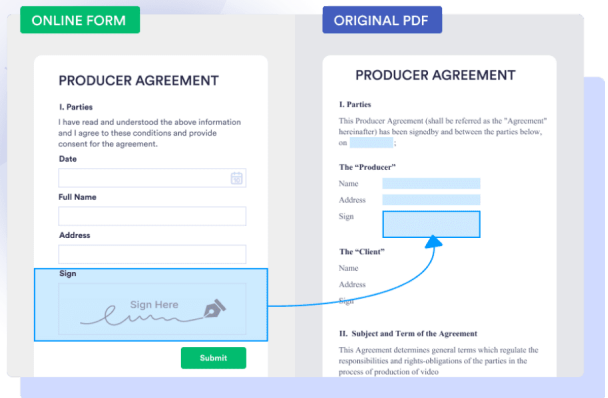
