The Buyer Agrees and Undertakes That:

- Buyer is of legal age to own a firearm and can lawfully receive or possess a firearm;
- Buyer is not under indictment or involved in any case pending in court for a crime with a punishment of imprisonment for more than one year, nor been convicted in any competent court for a crime punishable for the same;
- Buyer is not under a court order being restrained due to harassment, stalking, or threats against an intimate partner or the intimate partner's child, nor was convicted due to domestic violence;

- Buyer does not use any prohibited or unlawfully using controlled substances;
- Buyer has not been concluded or declared as mentally incapacitated or has been committed to a mental institution;
- Buyer is not admitted to the United States under a non-immigrant visa or is an illegal alien; or did not renounce his citizenship;
- Buyer was not dishonorably discharged from the armed forces;

The Seller Agrees and Undertakes That:

- The serial number etched on the firearm is legible and correct;
- He is the lawful owner of the firearm and has the right to dispose of the same;
- He has no knowledge of any hidden defects that was undisclosed to the Buyer;
- The firearm was not used on any acts of illegal in nature;
- The Seller shall transfer all rights and obligations to the Buyer upon transfer of ownership;

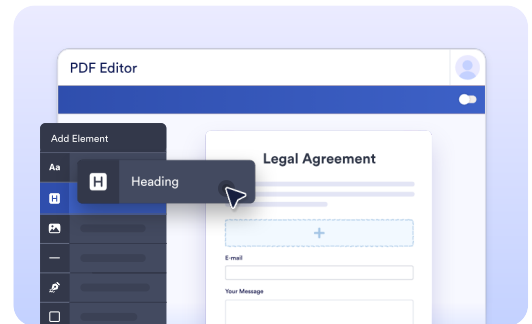

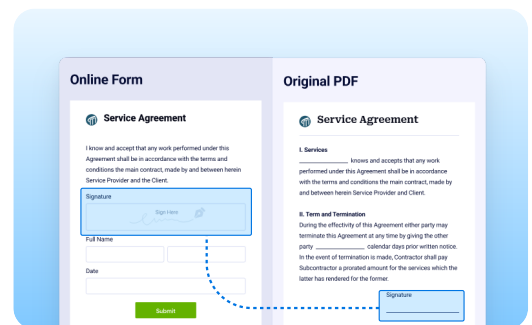

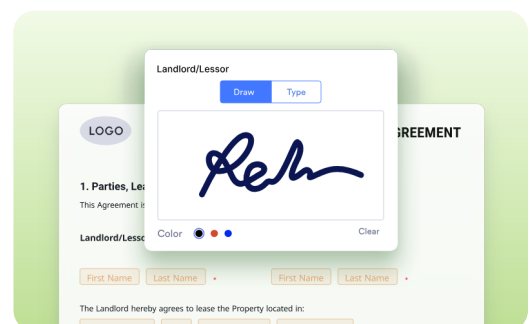
