This Security Deposit shall also cover in case the Tenant fails to pay the utility bills and outstanding rental debt.

V. UTILITIES

The Tenant shall be responsible for paying all utilities like electricity, water, gas, telephone, cable, and internet.

VI. MAINTENANCE AND DAMAGES

The Tenant shall use the property only for residential purposes. The Tenant shall keep the premises in good condition and shall follow reasonable standards of cleanliness.

Written permission from the Landlord is required for any alterations. If the Tenant makes alterations, renovations or changes without written permission, the Landlord has the right to request reinstatement.

The Landlord may enter the premises in a way that does not violate the Tenant's privacy, for the purposes of inspection, repair, maintenance, and emergency.

The tenant shall be liable for all the loss and damages arising from her/his use of the leasehold.

VII. OCCUPANCY and SUBLEASE

The number of occupants is limited to _____. Occupants will only be the Tenant and his/her family members.

The Tenant cannot allocate, transfer, or enter into a sub-lease relationship, in whole or in part, to a private or legal person.
