3. A missed payment during the period may result in the cancellation of this Agreement.
4. After the completion of this Agreement, the Lender shall provide a new payment scheme based on the remaining balance of my loan.
5. I cannot advance or pre-terminate this Agreement without the consent of the Lender.
6. Any interest owed by me during the rehabilitation period shall be capitalized and shall form part of the principal amount due.

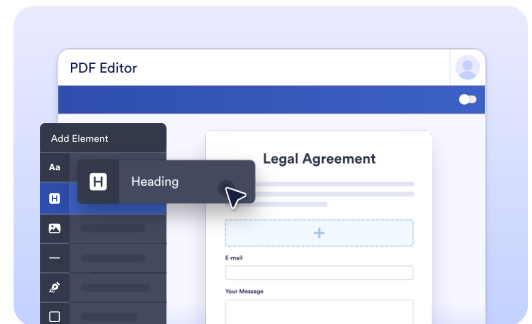

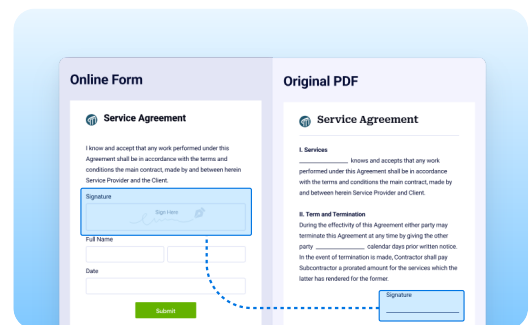

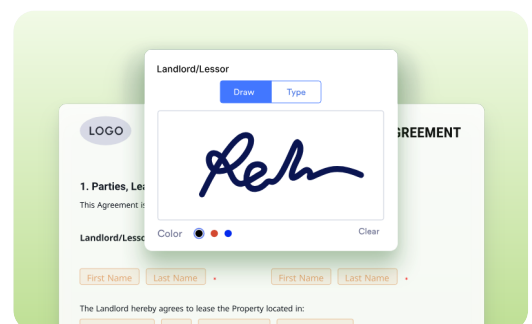
