Terms and Conditions

1. Purchase Price

The Purchase Price of the Dog equals to \$ _____ and is payable as follows:

2. Deposit

Buyer has paid a deposit of \$ _____, with payment of the balance of \$ _____ due upon release of the Dog to Buyer.

Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if:

- Buyer fails to complete the purchase of the Dog for any reason, or
- Buyer fails to pay the balance of the Purchase Price within _____ days of the agreed Delivery Date. In either event, Seller shall be free to sell the Dog to another party.

In the event that the Dog is not available due to sickness, death, or any other circumstance owing to the fault of Seller, Buyer's deposit will, at Buyer's option, be either (i) refunded, or (ii) transferred to the next litter of puppies.

3. Delivery

The Seller shall deliver the puppy to the Buyer on _____ at _____ at _____. If delivery is not possible on the specified date and time, the Seller and Buyer shall agree on an alternative delivery date and time.

The Buyer shall be responsible for all transportation costs associated with the delivery of the puppy, including but not limited to, transportation fees and travel expenses. The Seller shall ensure that the Dog is in good health and has received all necessary vaccinations before delivery.

A boarding fee of \$ _____ per day will be charged for each day the Dog is boarded by Seller past the agreed delivery date.

4. Transfer of Ownership and Registration

Upon payment in full of the Purchase Price, Seller (at Seller's sole cost) shall promptly take all actions required to officially transfer ownership and registration (if any) of the Dog to Buyer.

5. Seller's Representations and Warranties

The Seller represents and warrants that, to the best of their knowledge, the Dog is in good health at the time of sale and has received all necessary vaccinations and veterinary care.

The Seller further represents and warrants that the puppy is free from any known genetic defects or other conditions that would prevent the Dog from living a healthy life.

The Seller agrees to provide the Buyer with copies of any available veterinary records and certifications related to the Dog's health and genetic history. If the Dog is found to have any health issues within _____ days, the Seller agrees to provide a refund or replacement Dog, at their discretion.

This Guarantee does NOT cover Cherry eye, Entropion, Ectropion, Allergies, undescended testicles, loose knees or hips, Stenotic nares, elongated soft pallet, umbilical hernia, dermatitis, demodectic mange. The Seller will NOT replace the Dog due to heat stroke, abuse/neglect, or improper socialization.

To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, Seller will take the Dog back at any time during the Dog's lifetime. Seller will not issue a refund or provide another Dog to Buyer unless the Dog's return was a result of any misrepresentation on the part of Seller with respect to the Dog's health.

6. Buyer's Representations and Warranties

The Buyer represents and warrants that they are capable of providing a suitable home for the Dog, including but not limited to providing adequate food, water, shelter, exercise, and veterinary care.

The Buyer further represents and warrants that they have not been convicted of any animal cruelty or neglect offenses and have not had any pets confiscated or removed by animal control or similar agencies.

The Buyer agrees to provide the Seller with updates on the Dog's health and well-being upon request.

The Buyer agrees to have the Dog spayed or neutered by the age of six months.

The Buyer agrees not to sell, give, or release the Dog to a pet shop, retail store, dog dealer, animal testing facility, research facility, or an agent for any such business or facility.

7. Indemnity and Release

The Buyer agrees to indemnify and hold the Seller harmless from and against any and all claims, damages, losses, and expenses, including reasonable attorneys' fees, arising out of the Buyer's ownership or care of the Dog. The Buyer acknowledges that owning a pet carries inherent risks, including but not limited to the risk of injury or harm to the pet or others, and assumes full responsibility for these risks.

The Seller agrees to indemnify and hold the Buyer harmless from and against any and all claims, damages, losses, and expenses, including reasonable attorneys' fees, arising out of any misrepresentation or breach of warranty made by the Seller regarding the health or condition of the Dog.

Both parties agree to release each other from any claims or liabilities arising out of the sale, ownership, or care of the Dog, except as specifically provided in this Contract.

8. Miscellaneous

Entire Agreement. This Contract contains the entire agreement between the parties and supersedes all prior negotiations and understandings between the parties with respect to the subject matter of this Contract.

Modification. No amendment, modification, or waiver of any provision of this Contract shall be effective unless in writing and signed by both Parties.

Governing Law. This Contract shall be governed by and construed in accordance with the laws of _____.

Severability. If any provision of this Contract is held to be invalid, illegal, or unenforceable in any respect, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired.

Counterparts. This Contract may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
