

Safety Contract

This **Safety Contract** ("**Contract**") is entered into on _____ ("**Effective Date**") by and between the following parties:

Company

Individual

The Company and the Individual may be referred to individually as a "**Party**" and collectively as the "**Parties**".

1. Purpose

The purpose of this Contract is to establish clear expectations, responsibilities, and commitments regarding workplace health and safety. This Contract is intended to promote a safe working environment and to ensure compliance with applicable safety standards, internal policies, and operational procedures.

2. Scope of Application

This Contract applies to all activities performed by the Individual in connection with their role at or on behalf of the Company, including work performed on Company premises, at client sites, or remotely where applicable.

3. General Safety Obligations

The Individual agrees to:

- Perform all duties in a manner that prioritizes personal safety and the safety of others
- Comply with all Company safety policies, procedures, and instructions
- Use equipment, tools, and materials only as intended and in accordance with provided guidelines
- Immediately report unsafe conditions, incidents, or near-misses to the Company
- Refrain from engaging in behavior that could endanger themselves or others

The Company agrees to:

- Provide a reasonably safe working environment
- Establish and maintain appropriate safety policies and procedures
- Provide necessary safety training, information, and supervision
- Supply appropriate safety equipment where required
- Respond promptly to reported safety concerns

4. Safety Training and Awareness

The Individual acknowledges that they will:

- Participate in all required safety training sessions
- Follow instructions and guidance provided during such training
- Seek clarification where safety procedures are not understood

The Company shall maintain records of training and ensure that training materials are relevant to the Individual's role.

5. Use of Personal Protective Equipment (PPE)

Where applicable, the Individual agrees to:

- Properly use all required personal protective equipment
- Maintain such equipment in good condition
- Report any defects or need for replacement

The Company shall provide necessary PPE or specify requirements where the Individual must supply their own.

6. Incident Reporting and Response

The Individual must promptly report:

- Workplace injuries or illnesses
- Unsafe conditions or hazards
- Accidents involving equipment or property

The Company shall:

- Investigate reported incidents in a timely manner
- Take appropriate corrective actions
- Maintain records of incidents and resolutions

7. Compliance and Monitoring

The Company reserves the right to monitor compliance with safety requirements through supervision, inspections, and audits.

Failure to comply with safety obligations may result in corrective action in accordance with Company policies, which may include disciplinary measures or termination of engagement.

8. Term and Termination

This Contract shall remain in effect from the Effective Date for the duration of the Individual's engagement with the Company, unless terminated earlier.

The Company may terminate this Contract:

- For cause, including violation of safety obligations
- Without cause, upon reasonable notice

Upon termination, the Individual must immediately cease activities covered under this Contract and return any Company-provided safety equipment if requested.

9. Amendment

This Contract may be amended by the Company to reflect updates in safety standards, policies, or operational requirements. Any amendments shall be communicated to the Individual and shall take effect upon acknowledgment or continued engagement.

10. Governing Law

This Contract shall be governed by and interpreted in accordance with the laws of _____, without regard to conflict of law principles.

11. Acknowledgment

By signing this Contract, the Individual acknowledges that they have read, understood, and agree to comply with the safety obligations outlined herein. The Individual further acknowledges that adherence to safety requirements is a condition of their engagement with the Company.
