## TERMS AND CONDITIONS

**1. Services** - The Photographer agrees to provide photography services to the Client, including indoor and outdoor concept photoshoot, photocomontage and edit on photos, Digital delivery of all photographs taken in raw form and printed delivery of \_\_\_\_\_ selected photographs.

**2. Photoshoot Day/Time** - The photoshoot will be held on \_\_\_\_\_, at \_\_\_\_\_ . If the Client requests shooting at a different location, transportation costs are also covered by the Client. Unless the full contract price is paid, no change can be made on the specified day.

**3. Price and Payment** - The Client agrees to pay the Photographer the agreed-upon price for the photography services. 50% of this price shall be paid as deposit upon the concluding of this Agreement. This deposit is nonrefundable. Balance due shall be paid at least one day before the day of the photoshoot.

**4. Copyright** - The Photographer retains all copyrights to the photographs taken during the session or event. The Client is granted personal, non-exclusive rights to use the photographs for only personal purposes. Any commercial use, publication, or reproduction of the photographs without the Photographer's written consent is prohibited.

**5. Liability** - The Photographer shall take reasonable care to capture and deliver high-quality photographs. However, in the event of unforeseen circumstances or technical difficulties, the Photographer's liability is limited to a refund of the paid fees. The Photographer is not responsible for any damage, loss, or injury incurred during the session or event.

**6. Entire Agreement** - This Agreement constitutes the entire understanding between the parties and supersedes any prior agreements or understandings, whether written or verbal, relating to the subject matter of this Agreement.

**7. Governing Law** - This Agreement shall be governed and construed in accordance with the federal laws and applicable laws of the State of \_\_\_\_\_.

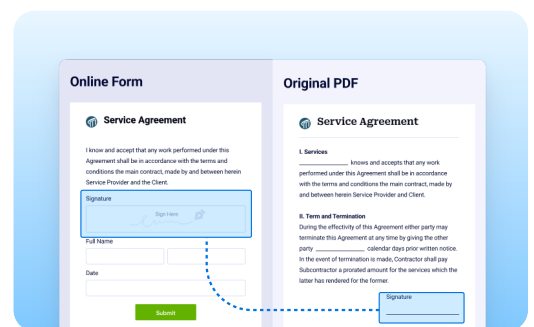
