



## Sport Contract

THIS AGREEMENT is made and entered this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, by and between Darthwood Sports Agency, a Limited Liability Company organized in Chicago Illinois, with the principal address at 431 Lake Shore Avenue, Chicago, Illinois 73431, represented in this Agreement by its President is Jonathan Harington (hereinafter known as "Agent" and \_\_\_\_\_, with residence at \_\_\_\_\_ (hereinafter known as "Player");

**WHEREAS**, Player desires to enter a basketball league that shall enable to develop Player's career in the field of sports mentioned.

**WHEREAS**, Agent is a full-service sports management agency who offers to represent as agent for the athletes acting on behalf of the latter for business arrangements and publicity;

**WHEREAS**, the Parties desire to enter into an agreement for Player to be represented by Agent for the sole exclusive representation of Player for business agreements and publicity, including enlisting Player with teams within and outside the United States Territory;

**NOW, THEREFORE**, in consideration of the foregoing premises, the parties agree as follows:

### Engagement

Agent is the sole and exclusive agent of Player. Agent shall be responsible for advising, assisting, and representing Player in connection with any engagement whether for publicity, endorsement, or performance, campaigns, including, but not limited to league engagements, that may utilize Player's skills, talents, and status. Agent shall introduce Player to sports organizations in which the latter may be interested. Agent shall be responsible for liaising any deals on behalf of Player and shall ensure to protect Player's interests in connection with the engagement.

### Compensation

Player agrees to pay Agent an agency fee amounting to \_\_\_\_\_ (\_\_\_\_\_) for every contract closed by Player during the effectivity of this Agreement. The termination of this Agreement shall not affect Agent's right to receive compensation due, including arrangements entered after the termination of this Agreement, provided that Agent is responsible for the introduction of such engagement.

### Term

This agreement shall begin on the day of execution stated above or upon the date signed by the Parties. This Agreement shall continue and remain effective for \_\_\_\_\_, unless renewed by the Parties hereto.

### Termination

Either Party may terminate this Agreement at any time before expiration provided that such notice must be given thirty (30) days prior date of effectiveness of such termination.

### No Employer-Employee Relationship

Parties agree that the relationship by them as contemplated in this Agreement shall remain a contract of Agency and shall never be of employer and an employee.

### Disputes

Parties agree that disputes arising out of this Agreement shall be resolved by them through amicable settlement before submitting their controversies before an arbitrator. The Parties shall equally contribute the cost of expenses for dispute resolution.

### Confidentiality

The terms and conditions in this Agreement constitute Confidential Information. Confidential Information shall refer to any and all kinds of information whether written or oral, made by either party to this Agreement or disclosed by their representatives to them in trust and confidence and are not of public record or information. In the event that the recipient of the confidential information is compelled by legal obligation by any governmental authority such as, but not limited to a court order, it shall be the responsibility of such party to notify the other so that the latter may be able to avail itself of appropriate remedies or waive compliance with the provisions hereof. The provisions of this section shall survive the termination of this Contract for whatever reason.

### Non-Waiver

The failure or nonperformance of the Parties in this Agreement with regard to demand for the compliance of their rights from the other shall not be construed as a waiver of said party. In the event that a party desires to waive his or her rights, such waiver must be made in writing and signed by the waiving party.

### Separability Clause

If any provision in this Agreement is declared void, ineffective, invalid, or contrary to law, the other provisions not affected by the said judgment or decree shall remain unimpaired unless said judgment affects the Agreement and the related documents as a whole.

### Counterparts

The Parties may execute this agreement in multiple counterparts, each of which is an original but all of which shall constitute one and the same instrument.

### Governing Law

The Parties agree that this Agreement is governed by the laws of the State of \_\_\_\_\_, to the exclusion of other state laws and without regard to international law.

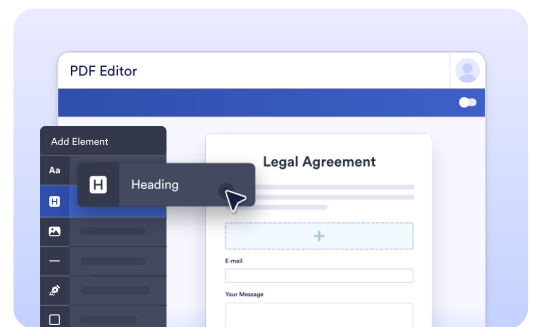

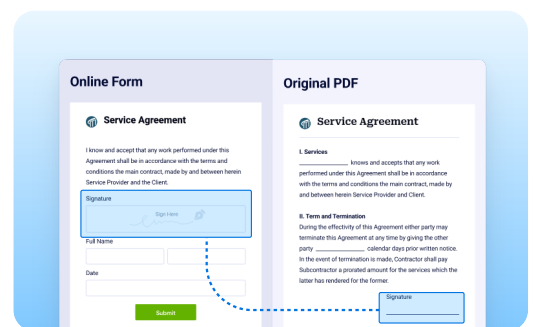
