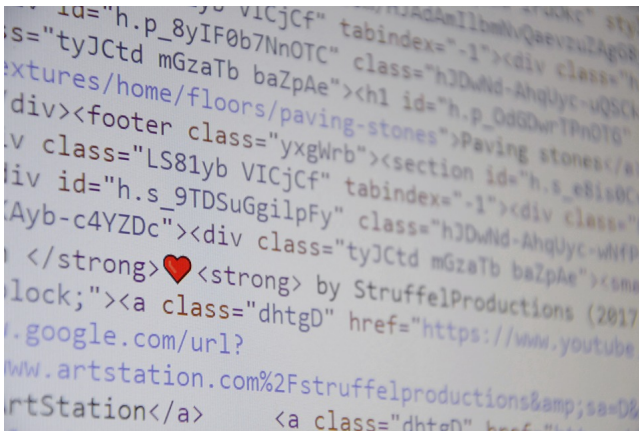


Planning

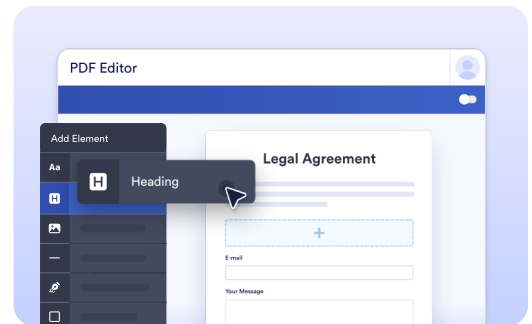

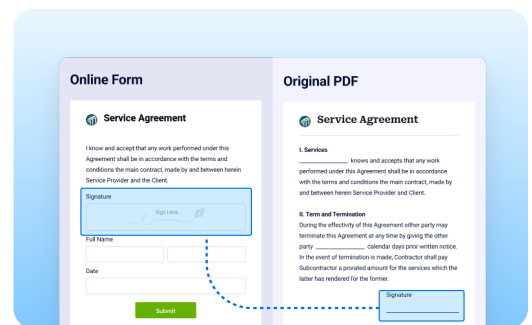

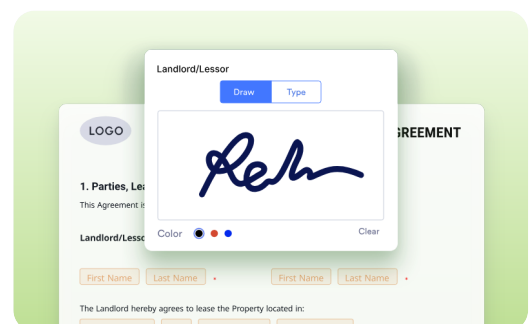
