

Wedding Vendor Contract

1. Parties

This **Wedding Vendor Contract** ("**Contract**") has been signed by and between the following parties;

The Vendor

The Organizer

WHEREAS, the Organizer operates a business providing space and facilities for wedding events and seeks to collaborate with experienced vendors to enhance the services offered to clients hosting events on its premises;

WHEREAS, the Vendor is engaged in the business of providing wedding event planning, coordination, and related services, including vendor management, decor, and logistical support to ensure successful event execution;

WHEREAS, the Organizer and Vendor wish to enter into this Contract to define the terms under which the Vendor will provide specified services to Organizer, subject to the Organizer's operational requirements;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties agree as follows:

2. Scope of Contract

The Vendor agrees to supply the following equipment and materials as requested by the Organizer for various wedding events held at different locations;

3. Pricing and Payment Terms

The Organizer agrees to pay Vendor based on a pre-approved fee schedule for each event, in accordance with the ordered materials and equipment. A deposit of _____ of the total fee is due upon placing the order, with the remaining balance due _____ after each event. Payments shall be made by _____.

Late payments are subject to a late fee of the outstanding balance. If payment is delayed beyond _____ after the due date, Vendor reserves the right to suspend further services until all outstanding invoices are settled.

In the event of a cancellation by the Organizer, the deposit remains non-refundable. For cancellations made less than _____ before the event, the Organizer will be liable for _____% of the total fee.

For events held beyond _____ of Vendor's primary location, Organizer will cover reasonable travel and accommodation expenses for Vendor staff as agreed upon in advance.

4. Possession of Equipment

Unless expressly agreed otherwise in writing, all equipment provided by the Vendor remains the sole property of the Vendor. The Organizer shall not acquire any ownership rights in the equipment by virtue of its possession, use, or payment for rental fees.

The Organizer is responsible for ensuring that the equipment is used solely for its intended purpose and handled with care during each event. Organizer agrees to take reasonable precautions to prevent damage, theft, or loss of Vendor's equipment while it is under the Organizer's supervision.

The Vendor is responsible for the timely retrieval of equipment following each event. Organizer agrees to make equipment available for retrieval at the agreed-upon time and ensure it is in the same condition as received, minus normal wear and tear.

The Organizer will be liable for any damage, loss, or theft of the equipment during the period it is in the Organizer's possession. Any repair or replacement costs will be invoiced to the Organizer, shall be paid _____ of receipt.

5. Independent Contractors

Nothing in this Agreement shall be construed to create a partnership, joint venture, or employment relationship between the Parties. The parties know and accept that the Vendor operates as an independent contractor.

6. Entire Agreement

This Contract constitutes the entire agreement between the Parties and supersedes any prior agreements or representations, even written or oral. Any amendments to this Contract must be in writing and signed by both Parties.

7. Force Majeure

Neither Party shall be liable for delays or non-performance due to causes beyond their reasonable control, including natural disasters, government restrictions, pandemics, or other unforeseeable events. If a force majeure event occurs, both Parties will work in good faith to reschedule the affected services.

8. Governing Law and Dispute Resolution

Any dispute that may arise within the scope of this Contract will first be tried to be resolved by reconciliation. Any lawsuit shall be filed in _____, _____. The Contract shall be governed by and construed in accordance with the laws of the State of _____.

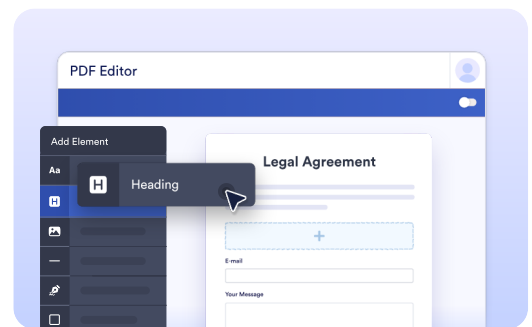

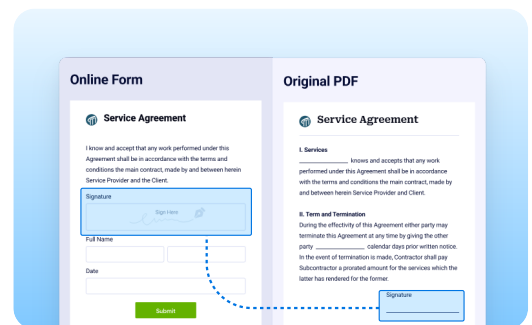

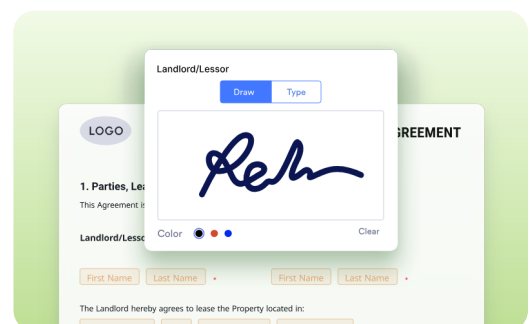
